



THANK YOU FOR CHOOSING TO PARTICIPATE AS A VENDOR AT THE ANNUAL LOS ANGELES CULTURE FESTIVAL® (LACF) ON HOLLYWOOD BOULEVARD.

Below you will find the Carnival Culture Village Vendor requirements and guidelines. Please be sure to enclose the following: Completed Vendor Application; Signed Waiver of Liability; Copy of Insurance Certificate; and a Copy of 501(c)3 or 501(c)4 non-profit status (if applicable).

Vendor Fees

Vendor applications will be accepted up to April 1st 2019. Selection of vendors is made by LACF based on vendor offering of service and capacity throughout. Vendor submission prior to deadline may facilitate early selection. Applications received after May 15th must include a \$100 late fee. Payment in full is due 7 days after notification of acceptance.

Vendor Deposit

In addition to vendor deposit application fees, there is a refundable security deposit due with your booth payment. There is a \$300 refundable security deposit due for food booths and \$100 for

return by the application deadline by April 30, 2023.

Art/Crafts and commercial booth. Vendor deposit will be mailed 15 business days following the event, once all terms of the contract are met. Vendor deposit will be automatically forfeitted if there are damages to tents, equipment, property, grease waste damages, alcohol, selling of unauthorized items etc.

Vendor Types

Food vendors are allocated a 10x10 Vendor Booth, in addition to a preparation 10'x8' area. Other vendors are allotted one 10X10 Vendor Booth space. The fees associated with each vendor type are outlined below:

Vendors and their employees, helpers etc. are not allowed to have alcohol in their booth. Alcohol can only be in the designated bar area in the village. Failure to comply will be forefeiture of security deposit, removal of personel from the village and/or suspension in future vendor participation in the village.

Vendor Space

Vendors are expected to provide their own tables and chairs however; they can be purchased through LACF at an additional cost.

Vendors are also expected to provide their own display boards and proper signage. Do not tape, tack, or otherwise affix any materials or signs to walls, trees, lamp posts or other surfaces on public or private property. Vendors should have a multipurpose fire extinguisher and first-aid-kit. Space assignments are determined based upon Vendor's Manager's discretion. This contract neither implies nor grants any

Vendor Responsibility

preferential location.

Each vendor must be present with their items during the vendor LACF Carnival Culture Village hours of operation. Each vendor is responsible for providing relief personnel to maintain their booth. No vendor may sublet to another vendor. Vendors must have their booth open and ready for business at the beginning of the designated opening hours and remain open through the designated closing time. Vendor will be responsible for any damages to the tent. Each vendor must abide by/comply with all Los Angeles Culture Festival® (LACF), and City of Hollywood rules, regulations, and ordinances.

No Vendor or their representative shall conduct themselves in a manner offensive to general standards of decency or good taste. The LACF committee Officials reserve the right to screen all booths and exclude inappropriate items. Loud music may not be played from any booth during your presence on the









festival grounds. In the event of inappropriate behavior, the booth will be forced to close and all fees will be forfeited.

Vendor Booth Tent Signage

It is the responsibility of each vendor to create their tent signage. The signs shall be attached to the pre-set tent.

Liability Insurance

All Vendors must submit a valid certificate of liability insurance of at least \$1,000,000 liability coverage; naming The Los Angeles Culture Festival® (LACF) as an additional insured. This certificate is available through your business insurance agent, and all vendors must have a valid business license.

Food Vendors

All Food vendors must display a current food permit from the Los Angeles Health Department. Contact our Vendor Booth Manager for food permit application.

Food Donations

Food donations by vendors are encouraged. We have a significant amount of volunteers and special guests we need to feed at the village, in exchange for you contribution we will accommodate your advertisment banner free and announce your company at the event.

Storage of Materials

During the LACF Carnival Culture Village hours of operation, all vendors must be confined within their area assigned. Vendors must plan for storage within their area when designing the configuration of their assigned booth.

Recycle & Waste Reduction

Recycle bins will be available for vendors and the public. We would like vendors to utilize those bins and GO "Green" throughout the LACF Carnival Culture Village. We also suggest you use more eco-friendly materials, and reduce the use of Styrofoam products. This will generate less waste.

Clean-Up

Vendor shall remove all personal property, trash and debris from their designated area throughout the duration of event. Each area will be inspected and cleared by LACF Committee Official upon departure. Vendors are required to use leak proof containers to store and transport grease waster after the event, LACF will not provide waste disposal or containers for grease waste. Failure to comply will result in the forfeiting of vendor deposit and additional costs incurred. Vendors must keep area sanitary at all times. Los Angeles Health Inspectors will conduct inspections throughout the event.

Rain or Shine

The Los Angeles Culture Festival® (LACF) will go on as scheduled and payments are non-refundable.

Terms of Contract

All Food, Arts & Crafts and Commercial booth vendors must accept the full terms of this contract.
